STATUTORY DECLARATION ON INSTITUTION WEBSITE UNDER SEC-4(1) (B) OF RTI ACT 2005.


Sec-4(1) (B) of RTI Act 2005 covers the statutory declaration of Nilambazar College Website (<https://nilambazarcollege.ac.in>).
