

4. In the interest of expanding educational opportunities, both the colleges agree to facilitate exchange programme as under:

#### I. Student Exchange Programme

#### i. Administrative Body

#### ii.Duration of Exchange

#### iii.Number of students

#### 7. Validity of MoU

This MoU will remain in force for five (05) years after which it may be extended on yearly basis, if both the college mutually agree.

- 8. The agreement shall be effective on and after the date of signing by the Head of the Institutions and remain in force for five(05) years or the date on which either party wishes to terminate during that period. In order to terminate a written notice of thirty days shall have to be served showing reason of termination.
- This MoU will be modified by the (ICCACEC) subject to the approval of IQAC of both the institutions.


